Software Changes

The following areas within the CAI Recording Program were modified or added in this release to comply with the changes in Senate Bill 1354 (63rd Legislature, Second Regular Session 2016).

- The period that a permit can be effective has been extended from 3 to 5 days.
- One five day extension of an approved catering permit is allowed.
- The Chief of Police and Fire Chief may attach conditions to catering permits to ensure public safety.
- Added the ability to print a completed application for signature and notary.

The changes in the law have resulted in the following changes to the Catering Permit portion of our Recording program.

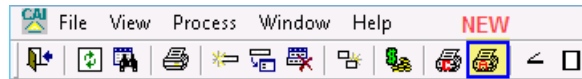
