

Per Idaho code 32-2020, changes to Marriage License age requirements.

- 1) Neither Applicant can be less than 16 years of age.
- 2) If either applicant age is less than (>) 18, and not less than 16 age, then other Applicant age cannot be 3 yrs. or older.

If age requirements are not met, Error appears.

You will not be able to proceed with Marriage license.
